## SUBJECT:Getting Buy-in For a Hospital Palliative Care Program – Webinar<br/>May 20 – 10:00 a.m. to noon

Hospital-based palliative care programs are rapidly expanding across the United States. Consider these facts:

- More than 50 percent of all hospitals now have a palliative care program.
- More than 75 percent of hospitals with more than 300 beds have a palliative care program.
- There is enormous variability in how healthcare institutions define a palliative care program.
- Ongoing financial strain makes it increasingly difficult to make the case for hospitals to support a palliative care program.

### Participants at this Webinar will be able to:

- Identify how to start, sustain and grow a palliative care program;
- Summarize the clinical, consumer, staff and business case for hospital palliative care;
- Recognize how to market your program to hospital administrators and physicians; and
- Describe methods for aligning a palliative care program with key hospital issues of mortality, cost reduction and patient/family satisfaction.

## This Webinar is the first step in building a palliative care program at your facility. In Sept. we will have an in-depth, step-by-step session to further assist you in establishing your program.

**FACULTY:** *Dr. David E. Weissman* is a professor emeritus and founder of the Medical College of Wisconsin Palliative Care Center. In 1991, he began one of the first palliative care programs in the United States. In 2003, the Medical College of Wisconsin's Palliative Care Program was designated as one of six United States *Palliative Care Leadership Centers* by the Center to Advance Palliative Care. Dr. Weissman serves as a consultant to the Center to Advance Palliative Care and also runs a consulting practice for hospitals and health systems, *Palliative Care Education, LLC*.
