Telehealth's Applications for Preparedness and Response

Telehealth can and should be a key component of both community preparedness planning and post-crisis response strategies. Additionally, certain telehealth applications can be used in daily operations to help expand existing capacity at points of care. Situation Report: Measles

From January 1 to March 14, 2024, the Centers for Disease Control and Prevention (CDC) has recorded 58 confirmed cases of measles across 17 jurisdictions in the United States. These cases have been attributed to seven outbreaks, compared to the 58 total cases in four outbreaks reported throughout

the entirety of 2023. Ninety-three percent of the reported cases in 2024 are linked to international travel. Among the affected individuals, the majority are children aged 12 months and older who have not received the measles-mumps-rubella (MMR) vaccine.

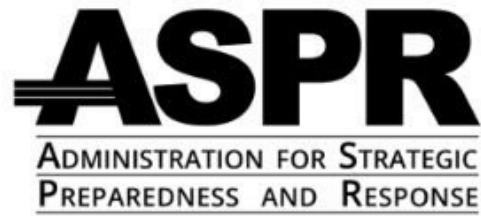
